Graphs in Uniformly Accelerated Motion along a straight line $(a \neq 0)$

- $\quad x$ is a quadratic polynomial in terms of $t$. Hence $x-t$ graph is a parabola.


x-t graph
- $v$ is a linear polynomial in terms of $t$. Hence $v-t$ graph is a straight line of slope a.




## v-t graph

- a-t graph is a horizontal line because a is constant.



## Maxima \& Minima

## CROSSING RIVER

A boat or man in a river always moves in the direction of resultant velocity of velocity of boat (or man) and velocity of river flow.

## 1. Shortest Time :



Velocity along the river, $\mathrm{v}_{\mathrm{x}}=\mathrm{v}_{\mathrm{R}}$.
Velocity perpendicular to the river, $\mathrm{v}_{\mathrm{f}}=\mathrm{v}_{\mathrm{mR}}$
The net speed is given by $v_{m}=\sqrt{v_{m R}^{2}+v_{R}^{2}}$

## 2. Shortest Path :

velocity along the river, $\mathrm{v}_{\mathrm{x}}=0$
and velocity perpendicular to river $v_{y}=\sqrt{v_{m R}^{2}-v_{R}^{2}}$
The net speed is given by $\mathrm{v}_{\mathrm{m}}=\sqrt{\mathrm{v}_{\mathrm{mR}}^{2}-\mathrm{v}_{\mathrm{R}}^{2}}$

at an angle of $90^{\circ}$ with the river direction. velocity $\mathrm{v}_{\mathrm{y}}$ is used only to cross the river,
therefore time to cross the river, $t=\frac{d}{v_{y}}=\frac{d}{\sqrt{v_{m R}^{2}-v_{R}^{2}}}$
and velocity $\mathrm{v}_{\mathrm{x}}$ is zero, therefore, in this case the drift should be zero.
$\Rightarrow \quad \mathrm{v}_{\mathrm{R}}-\mathrm{v}_{\mathrm{mR}} \sin \theta=0 \quad$ or $\quad \mathrm{v}_{\mathrm{R}}=\mathrm{v}_{\mathrm{mR}} \sin \theta$

A weighing machine does not measure the weight but measures the force exerted by object on its upper surface.

## FRICTION

Friction force is of two types.
(a) Kinetic
(b)
Static

KINETIC FRICTION: $f_{k}=\mu_{k} N$
The proportionality constant $\mu_{\mathrm{k}}$ is called the coefficient of kinetic friction and its value depends on the nature of the two surfaces in contact.

## STATIC FRICTION :

It exists between the two surfaces when there is tendency of relative motion but no relative motion along the two contact surfaces.
This means static friction is a variable and self adjusting force. However it has a maximum value called limiting friction.

## - Kelvin- Planck Statement

It is impossible to construct an engine, operating in a cycle, which will produce no effect other than extracting heat from a reservoir and performing an equivalent amount of work.

## - Rudlope Classius Statement

It is impossible to make heat flow from a body at a lower temperature to a body at a higher temperature without doing external work on the working substance

## Entropy

## 7. Growth Of Current in Series R-L Circuit

If a circuit consists of a cell, an inductor $L$ and a resistor $R$ and a switch $S$ ,connected in series and the switch is closed at $\mathrm{t}=0$, the current in the circuit $I$ will increase as $I=\frac{\varepsilon}{R}\left(1-e^{\frac{-R t}{L}}\right)$

The quantity $\mathrm{L} / \mathrm{R}$ is called time constant of the circuit and is denoted by $\tau$. The variation of current with time is as shown.

A ray travelling along the path of the reflected ray is reflected along the path of the incident ray. A refracted ray reversed to travel back along its path will get refracted along the path of the incident ray. Thus the incident and refracted rays are mutually reversible.

## 10. Dispersion Of Light

The angular splitting of a ray of white light into a number of components and spreading in different directions is called Dispersion of Light. This phenomenon is because waves of different wavelength move with same speed in vacuum but with different speeds in a medium.
The refractive index of a medium depends slightly on wavelength also. This variation of refractive index with wavelength is given by Cauchy's formula.
Cauchy's formula $n(\lambda)=a+\frac{b}{\lambda^{2}}$ where $a$ and $b$ are positive constants of a medium.
Angle between the rays of the extreme colours in the refracted (dispersed) light is called angle of dispersion.
For prism of small 'A' and with small ' $i$ ' : $\quad \theta=\left(n_{v}-n_{r}\right) A$

## Amplitude Modulation

- The modulated signal $\mathrm{c}_{\mathrm{m}}(\mathrm{t})$ can be written as
$C_{m}(t)=A_{c} \sin \omega_{c} t+\frac{\mu A_{c}}{2} \cos \left(\omega_{c}-\omega_{m}\right) t-\frac{\mu A_{c}}{2} \cos \left(\omega_{c}+\omega_{m}\right)$
- Modulation index $m_{a}=\frac{\text { Change in amplitude of carrier wave }}{\text { Amplitude of original carrier wave }}=\frac{k A_{m}}{A_{c}}$ where $\mathrm{k}=\mathrm{A}$ factor which determines the maximum change in the amplitude for a given amplitude $E_{m}$ of the modulating. If $k=1$ then
$m_{a}=\frac{A_{m}}{A_{c}}=\frac{A_{\text {max }}-A_{\text {min }}}{A_{\text {max }}-A_{\text {min }}}$
- If a carrier wave is modulated by several sine waves the total modulated index $m_{t}$ is given by $m_{t}=\sqrt{m_{1}^{2}+m_{2}^{2}+m_{3}^{2}+.}$ $\qquad$
- Side band frequencies
